She also served on the Chapter 7 panel of trustees in Colorado by appointment of the United States Trustee.

**Kyler K. Burgi, Esq.**, Davis Graham & Stubbs LLP, focuses his practice primarily on complex commercial litigation, bankruptcy and creditors' rights, and toxic tort litigation. Before joining DGS, Mr. Burgi served as a law clerk to the Honorable Philip A. Brimmer of the U.S. District Court for the District of Colorado where he assisted in a wide variety of civil and criminal matters. He received his J.D. from the University of Denver Sturm College of Law.

**Leo M. Weiss, Esq.**, as Trial Attorney, 1988-2017, United States Trustee's Office, Denver, presented numerous Continuing Legal Education programs for the Chapter 7 Panel Trustees and Bankruptcy Bar on a variety of topics in bankruptcy-related areas.
