

Elder financial exploitation is a national problem that is expected to escalate. Victim consequences include financial loss, diminished emotional, psychological, physical health and earlier death. Family members have been identified as the largest perpetrator group in part because older adults are unaware of risk factors that could lead to EFFE. However, prevention to reduce the consequences to elders, their families and to society is more complicated than merely including accountability in POA documents. This session will include research findings identifying factors within families that can help lawyers and their middle-aged and older clients proactively address family problems to increase protective factors and reduce risk factors of EFFE.
