

#### FEATURED PRESENTATION: Implicit Bias and Cultural Competency Workshop

Implicit Bias, or subconscious bias, continues to grow as a theory of discrimination in both disparate treatment and disparate impact cases under Title VII and state law. The terms themselves, and the definitions of subconscious and implicit bias, are not always well understood. This workshop will identify and describe implicit bias and address its impacts in the workplace, within schools, and from law enforcement. Then, we will survey common methods employers use to address implicit bias and propose a mindfulness model that has shown promise in addressing implicit bias in a controlled study.

Crossing boundaries to promote inclusion, culturally responsive service, and equal opportunity requires engagement not only from those who are sensitive to cultural diversity, but also from police officers, educators, administrators, and other professionals. This workshop will explain implicit bias using evidence-based theories, build a conversation on how implicit bias impacts our community, and discuss the best ways to educate and overcome the biases we all have.
