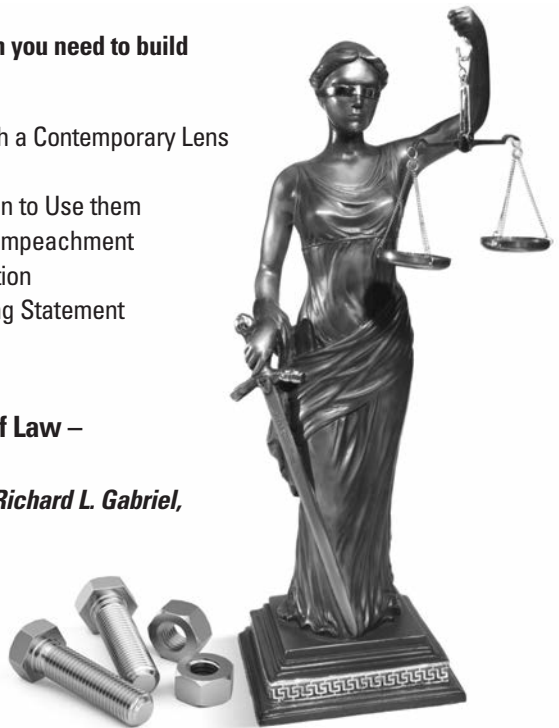

PROGRAM CHAIR

Jerry R. Bowman, Esq., is a personal injury lawyer and the co-founder of Bowman & Chamberlain LLC. Before then he was in private practice for 20 years, where he focused on commercial, intellectual property, probate, and products liability litigation, including appeals.

David M. Johnson, Esq., has practiced law for more than 40 years and has practiced family law exclusively for over 32 years. He has served as a family court magistrate judge in El Paso County and since 1997 has concentrated on complex family law cases involving children's issues and high value marital estates. He also has an active and growing practice as a mediator and mediator-arbitrator.
